# NOTICE TO EXHIBITORS

This is an AKC Sanctioned Obedience Trial, given by a licensed Obedience Club; therefore, American Kennel Club rules and regulations will be strictly enforced.

Telegraph, Telephone, and unsigned entries cannot be accepted. Entries not on official AKC entry forms and photocopies of the entry form without Agreement and rules on reverse side of the Official AKC entry form are NOT ACCEPTABLE.

Entries without fees will not be accepted. Acknowledgment of entries will be made as soon as practical with tickets and/or identification card. The person accompanying the dog must show tickets of admission and identification before the dog will be received. Should such acknowledgment not be received by the exhibitor, please notify trial secretary.

A recording fee of .50 will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. This recording fee is to be collected by the Show giving club and paid to the American Kennel Club. If a dog is entered in more than one class in the same show, the recording fee will be collected on the first entry only. (AMERICAN KENNEL CLUB rules, Chapter 14, Section 2)

Entry fees shall not be refunded in the event that a dog is absent, excused by the Veterinarian or Judge, or barred from competition by the actions of the Show Committee. Bitches in season are not eligible for competition and will not be permitted on the grounds and entry fees will not be refunded in any case. If, because of riot, civil disturbance or other acts beyond the control of the management, it is impossible to open or to complete the show, no refund of entry fees will be made. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

Dogs may arrive at any time prior to their scheduled time of judging. Dogs not required for further judging will be excused. All dogs present must be held on leash or confined to their crates except when being judged.

No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

Errors on entry blanks. Owners are responsible for errors in the making out of entry forms, whoever may make such errors or cancellation of entries after the published closing date.

**From Red Roof Inn and Laquinta Inn:** US-258 West, left on Queen Street (approx. .2 miles). Slight right onto Powhatan Pkwy (approx. 2 miles). Left at 2<sup>nd</sup> light onto Pembroke Avenue. Shortly before the 1<sup>st</sup> traffic light, turn left onto Newsome Place. MDTC facility is the 2<sup>nd</sup> building on your left.

**From Super 8 Motel:** Turn left onto Armistead Ave. Turn right onto Pembroke Avenue. Turn right onto Newsome Place immediately after 2<sup>nd</sup> traffic light. MDTC facility is the 2<sup>nd</sup> building on your left.

**From the North:** Take I-64 East. Take I-664 South (Exit 264), to Powhatan Pkwy (Exit 2). Turn left at traffic light. Turn left at second traffic light onto Pembroke Avenue. Shortly before the 1<sup>st</sup> traffic light, turn left onto Newsome Place. The MDTC facility is the 2<sup>nd</sup> building on your left.

**From the South:** Take I-64 West through the Hampton Roads Bridge Tunnel. Take Armistead Ave/VA-134 West exit (Exit 265B) towards La Salle Ave (VA-167 North). Merge onto VA-134. ## AGREEMENT

I (we) acknowledge that the " Rules Applying to Registration and Dog Shows" and, if this entry is for an Obedience trial, the "Obedience Regulations," have been made available to me (us), and that I am (we are) familiar with their content. I (we) agree that the club holding this show or obedience trial has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the show or obedience trial and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies. I (we) agree to hold this club, its members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employee of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the show or obedience trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog by disappearance, theft, damage, or injury , caused by negligence of the club or any of the parties aforementioned, or by the negligence of any person, or any other cause or causes. - (Variety) if you are entering a dog of a breed in which there are varieties for show purpose, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti- color), Beagle (not exceeding 13 in. over 13 but not exceeding 15 in.), Dachshunds (long-haired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terrier (standard, toy), Chihuahua (smooth coat, long coat), English Toy spaniel (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of records and dogs which according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Championship Best of Breed competition is limited to a period of 90 days from the date of the show which the dog completed the requirements for a championship.
- (Dog Show Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to A.K.C. (For complete rules refer to Chapter 14, Section 3.)
