This is an AKC Sanctioned Obedience Trial, given by a licensed Obedience Club; therefore, American Kennel Club rules and regulations will be strictly enforced.

Telegraph, Telephone, and unsigned entries cannot be accepted. Entries not on official AKC entry forms and photocopies of the entry form without Agreement and rules on reverse side of the Official AKC entry form are NOT ACCEPTABLE.

This recording fee is to be collected by the Show giving club and paid to the American Kennel Club. If a dog is entered in more than one class in the same show, the recording fee will be collected on the first entry only. (AMERICAN KENNEL CLUB rules, Chapter 14, Section 2)
Entry fees shall not be refunded in the event that a dog is absent, excused by the Veterinarian or Judge, or barred from competition by the actions of the Show Committee. Bitches in season are not eligible for competition and will not be permitted on the grounds and entry fees will not be refunded in any case.
