Training Classes / Testing / Titles

Basic Class - a basic training course for dogs aimed at training you to train your dog. Emphasis is on the basic training needed to make the dog a good companion. You and your dog will be taught the 10 basic exercises needed to pass the Canine Good Citizen test which include: heeling on a loose leash, sit, stand, down, stay in position, and come when called. **Canine Good Citizen Test** - is offered by AKC dog clubs and that includes **PCOTC**. You and your dog will need to know 10 exercises taught in a basic training class. The CGC test is a pass or fail test and may be retaken if necessary. The set of 10 exercises are meant to demonstrate confidence and control of your dog and are not a competition.

Advance Class – is for owners/dogs who have passed their CGC test and wish to continue training to strengthen their skills and the bond between owner and dog. Aimed at helping to prepare for Obedience/Rally Trails if that is the owners intent, but not the sole purpose of the class.

AGREEMENT TO HOLD HARMLESS, WAIVER AND ASSUMPTION OF RISK
